#### MTN VOICE ACASI EQUIPMENT

Each participating VOICE study site has been provided with the following ACASI equipment:

- Touch screen ACASI computers (each equipped with a 2GB Secure Digital (SD) storage card) and chargers (touch screen computer)
- Designated ACASI laptop computer for Data Manager function and charger (data manager computer)
- USB portable data storage device ("USB key")
- Audio headphones
- Stylus
- One Extra battery for each ACASI computer (in case of brown outs at the site)

The above-listed equipment may be used for purposes of ACASI data collection and transfer only. The equipment should not be used for any other office, business, or leisure activities. No additional software should be installed on any of the computers and the computers should not be used for word processing, browsing the Internet, or any other application. No technical changes should be made to any of the equipment unless directed by ACASI support personnel at the Population Council or MTN Statistical and Data Management Center (SDMC) i.e. SCHARP.

In the event that the laptop battery loses power, the touch screen ACASI computers are configured to automatically power down and go into hibernation. In this state the laptop will save whatever is on the screen to disk. The depleted laptop battery can then be replaced with a charged battery and the unit can then be turned back on. After turning on the touch screen computer, the power-on security password (see p.6 item#3) will need to be entered, and then the laptop will display the screen as it was before going into hibernation. It is important to keep all touch screen laptop batteries charged and available for use so that they can be available during power outages.

Please note that if you flatten the screen over the keyboard, you will need to adjust the orientation of the display by clicking the Swivel button. This button is on the bottom of the display, to the left of the center, and has an icon that shows a landscape changing to portrait display.

ONLY the data manager computer can be connected to the internet, and only when uploading data to the SCHARP ATLAS portal. For computer security reasons, no touch screen computer should ever be connected to the internet.

Each participating study site must specify in its site specific data management standard operating procedures (SOPs) for MTN-003 (VOICE) where the above listed equipment will be securely stored and which study staff are authorized to access the equipment. Study staff designated as responsible for proper storage of the touch screen computers should perform the following daily maintenance tasks with each touch screen computer on each workday:

- Turn on the touch screen computer and enter a valid User ID (see below for more information on User IDs)
- Verify that the touch screen computer boots up properly and is functioning
- Verify that the assigned (labeled to match computer name) SD card has been inserted in the touch screen computer
- Verify that a stylus is present in the stylus slot of the touch screen computer

- Clean the touch screen computer screen with cloth. DO NOT use liquid cleanser or water
- Charge the touch screen computer and ensure the battery is full at the start of each work day (in case of unexpected brown outs)

At the end of each workday, after performing required data backup and transfer tasks, study staff designated as responsible for proper storage of the touch screen computers and the data manager computer should ensure that the computers have been properly turned off and plugged in to recharge the batteries. Place the computers in a secure, dry location until the next day of use.

#### MTN VOICE ACASI USER ID NUMBERS

Each participating VOICE study site has been provided three different types of User ID numbers to be assigned to study staff involved in collecting and transferring ACASI data, as follows:

- ACASI Administrator: persons responsible for administering ACASI interviews with study participants
- ACASI Computer data managers: persons responsible for performing ACASI data back-ups and transfers to the MTN SDMC (i.e. SCHARP)
- Investigator (or designee): persons responsible for carrying out duties of the Computer data manager should that person not be available

Each ACASI Computer data manager and Investigator is assigned his/her own unique ACASI Administrator ID, as well as his/her own unique Windows login and password. The Windows logins are used on the data manager computers.

User IDs will be assigned to study staff using assignment forms provided in sealed envelopes. As User IDs are assigned, each staff member assigned an ID must sign and date his/her assignment form to acknowledge receipt of his/her User ID. Signed original forms should be maintained with other MTN VOICE Essential Documents related to study staffing. A copy of each signed form should be provided to Barbara Mensch or Stan Mierzwa at the Population Council. Also contact Barbara Mensch (BMENSCH@popcouncil.org) or Stan Mierzwa (SMIERZWA@popcouncil.org) if additional User IDs are needed.

#### NOTES ON SECURITY:

- Study staff to whom ACASI User IDs are assigned should not share their User IDs or passwords with anyone else.
- Each staff member should always use the same User ID and password.

#### MTN VOICE ACASI ADMINISTRATOR REFERENCE

Refer to Appendix A for general guidelines on setting up the participants for the ACASI interview

#### **Turning on the Touch-Screen Laptop Computer (Figure 1)**

- 1. Open the cover and press the silver button to turn on the laptop.
- 2. Retrieve the stylus from the left side of the computer by pressing it until it pops out.
- 3. A few seconds after the computer has been turned on, you will see a picture of a lock, which indicates that you need to enter the password. The power-on security password is **dvd15**




#### **Administrative Setup (Figure 2-Figure 9)**

As the ACASI Administrator, you will be prompted to enter some information into the computer before the participant practice session and subsequent ACASI interview. There is no audio associated with entry of this information. <u>Note</u>: must use dropdown menu for questions below for data to be accepted.

You will be prompted to enter:


- Your Administrator ID
- The Participant ID number (PTID)
- The visit code
- The visit date
- The questionnaire language
- The participant's number of live births (per her self-report at the time of the ACASI interview)
- The participant's age (per her self-report at the time of the ACASI interview)
- The number of days the participant went to the market in the past seven days (per her self-report at the time of the ACASI interview)

The administrator should enter all required information using either the physical keyboard or the screen keyboard and the stylus or mouse. If you are using the screen keyboard and you need to enter a number, tap into the box that requires the number and the keyboard (Figure 2) should appear on the screen



#### **Entering the Administrative Information**

 Administrator ID (Figure 3): Each ACASI Administrator has been assigned an ACASI user ID. Enter this ID as your Administrator ID by tapping on the keyboard screen with the stylus (or clicking with the mouse) and then tapping the green Submit button. Your ID will be masked, since it also serves as a security procedure for accessing the program.



2. On the next screen, tap the **New Survey** button (Figure 4).



3. On the next screen (Figure 5) select the appropriate questionnaire by tapping the correct bar and then tapping the START SURVEY button.




4. Enter the correct PTID in the Participant ID field (Figure 6). NOTE: If you entering test data, it is important that you enter one of the Test PTIDs listed in Appendix B of this document. Any Test PTID can be used, and Test PTIDs can be used more than once. Confirm that the correct PTID was entered by entering it a second time, and then tap the green Next button. In addition to confirming the PTID was entered in twice, when you click the green Next button, a check is made to ensure the PTID is valid as provided by SCHARP. If the PTID is not valid, you will be prompted to enter a valid PTID.






- 5. Select the correct visit code (Figure 7). You will select the appropriate visit code using the drop-down menus. Note that there is no built in validation for visit codes. It is the administrator's responsibility to ensure that the correct visit code is selected. When done, tap the green Next button.
- 6. Confirm the visit date (Figure 7). The visit date will be filled automatically using the numeric format dd/mm/yyyy (for example, 17/04/2009) but you must also confirm the visit date by selecting the appropriate two-digit day, three-character month, and 4-digit year from the dropdown menu.
- 7. Choose the appropriate ACASI language from the drop-down list (Figure 8).
- 8. Ask the participant how many children she had that were born alive and select that number from the pull down menu (Figure 8). Note: It is not necessary to obtain or verify the number of live births from the participant's study records. The number entered will have to match the number that will be entered for Practice Question 2 (PQ2)
- 9. Ask the participant how old she is and select the corresponding age range from the pull-down menu (Figure 8). It is not necessary to obtain or verify her age from the participant's study records The range entered will have to match the range entered in Practice Question 3 (PQ3)
- 10. Ask the participant on how many days she went to the market in the past 7 days and select that number from the pull down menu (Figure 8). The number entered will have to match the number entered for Practice Question 4 (PQ4)



11. After completing the above steps, tap the green Next button. A screen with a bar labeled "PRACTICE QUESTIONS" will appear (Figure 9). DO NOT tap the "PRACTICE QUESTIONS" bar until you have set up the participant for the interview and are ready to turn over the computer to her.



12. Turning the computer screen around

Before turning over the computer to the participant, you must turn the screen around as described below.

With one hand on the base/keyboard, use your other hand to twist the screen away from you to the left, in the direction of the arrow that you will see where the keyboard and display are connected.

#### Setting Up the Participant for the Interview

Refer to the ACASI training script on page 16 of this manual to set up the participant for the interview and begin the ACASI training session.

**Audio-headphone training:** Connect the headphones to the touch screen computer by plugging them into the green port. Ask the participant if she has ever used headphones before and show her how they work, including using the dial on the cable/wire to adjust the volume.

Show the participant how to put the headphones on. The side of the headphone labeled R should cover the right ear and the side labeled L, the left ear.

**Stylus/touch screen training:** The participant should be shown how to use the stylus – tap lightly and as straight as possible. For most questions participants may tap the black square, the red square, yellow square, numbered boxes, or a picture. If they tap on a picture, each tap will be counted towards the total for that question. She may tap up to 60 times for each question that involves a number. For instance, if she had four children, she would tap on the picture of the child four times.

#### Additional Instructions: Instruct the participant on the following:

- If she wants to change her answer to the previous question, she can tap the white (Previous) button. She can only go back to the question immediately preceding the current screen, after that, the previous button will be grayed out.
- If she has any other problems or would like to stop the interview for any reason, she should let you know. (Advise her on where to find you. You should be nearby so she can find you easily, but for privacy reasons you should not stay in the same room as the participant when she is doing her interview)
- If she would like to skip a question, the participant may press the small white circle in the center, at the bottom of the screen.

#### **Practice Questions**

Practice questions are to be conducted at Enrollment visit and First Quarterly Visit (at minimum), and any other visits as needed. After you have prepared the touch screen computer for the participant (steps 1-12 on page 6-10) and are ready to train the participant on how to use the computer using the practice questions, tap the "PRACTICE QUESTIONS" button to begin the practice questions. Refer to the ACASI training script on page 16 of this manual to begin the ACASI training session. You may want or need to review the practice questions multiple times with each participant during the training/practice session. One option is to go over the first practice question without earphones so as to provide guidance and explanation to the participant.

Sit next to the participant while she answers the practice questions.

There are five practice questions:

- 1. Are you a woman?
- 2. How many children have you given birth to who were alive at birth? (Figure 10)
- 3. What is your age?
- 4. In the past 7 days, on how many days did you go to the market?
- 5. The fifth practice screen is a set of questions which ask whether the participant has eaten a meal for each day in the past week (Figure 11)

The text of each question will appear on the computer screen in the language that is selected during the administrative setup and will be accompanied by an audio recording of the questions that the participant will hear through the headphones. The participant will need to provide the correct answer to each question in order to move to the next question.

Please note: the responses to the practice questions responses are not stored






Once the participant has answered the practice questions, there will be 2 options (Figure 12):



- 1) You can have the participants repeat the practice questions by tapping the "REPEAT PRACTICE QUESTIONS" button.
  - Select this option if you think the participant needs more practice before beginning the MTN VOICE ACASI interview.
- 2) You can have the participant proceed to the MTN VOICE ACASI interview questions by tapping the "BEGIN QUESTIONNAIRE" button.
  - Select this option if you think the participant is ready to proceed to the actual MTN VOICE ACASI interview questions. Before proceeding, one addition guidance point to explain to the participant is that while she hears some of the longer audio files which introduce sets of related questions, she will see a simple graphic such as the ones shown below (Figure 13).

Once the participant has completed the practice questions and begins the MTN VOICE ACASI interview, you should leave the room. You should however, wait outside the interview room so that you are available should the participants have any questions or problems.

#### **Exiting the ACASI Program**

At any time, you may terminate the interview application by double tapping or double clicking on the


top left corner of the screen where you see the small white square with a black border . A gray box will pop up, asking if you would like to exit the survey. During the administrative setup, you may double tap on the MTN logo to exit the program.

Please note, each time an interview is completed, the computer will automatically reboot and take you back to the initial login screen.

#### Things to Keep in Mind

- If the participant lacks numerical literacy, or if the participant is unable to correctly use ACASI after multiple attempts with practice questions, the participant should not complete the ACASI Enrollment Questionnaire. Document in the participant's chart notes that she is unable to complete the ACASI questionnaire and specify the reason(s). Mark the "no" box for item 4 on the Enrollment CRF and record the reason(s) the questionnaire was not completed. Have **another administrator** (if possible) conduct the practice questions with the participant at her first quarterly ACASI. If again , she is unable to use ACASI, repeat steps above. For more detailed information on procedures for this situation, refer to Data Communique #2 posted on the MTN website SSP Manual Section 15: http://www.mtnstopshiv.org/node/1077.
- There are internal checks built into some of the practice questions, this is by design. The
  responses must agree with each other, specifically for questions regarding the participant's age,
  number of children, and number of days she went to the market. She will be prompted to try the
  question again if the answer she gives during the practice questions does not agree with the
  answers that you entered in the administrative section.
- There are no validation checks for the visit code number entered by the administrator. Please
  make sure you double check that the correct visit code has been entered when completing the
  administrative section
- If there are any program or computer failures during an interview, please write down the question number and the context in which the error occurred. As much information as possible about the situation that brought about the error would be useful for correcting the problem. If the error causes the interview program to stop, you should exit the program and restart it.

- If an interview is terminated that is only partially completed, the participant will need to start from the beginning with a new interview. The interview program will allow one study participant to complete the interview more than once, but the data from each interview will be saved separately.
- If participant misses her Month 3 Visit, administer the First Quarterly Oral ACASI questionnaire at the first quarterly visit she completes. The first quarterly ACASI questionnaire is the exception, no other type of ACASI questionnaire will be made up. This is because product sharing is asked in the first quarterly ACASI and then not again until her month 12 questionnaire. If a participant misses her first quarterly, waiting until Month 12 is too long to obtain data on product sharing.
- If a participant **misses her Month 12 visit**, SKIP the annual ACASI questionnaire and administer the regular quarterly questionnaire at her next scheduled quarterly visit (i.e. her month 15 visit).
- You may need to respond to specific questions the participant may have about how to enter their
  response or about the interview questions. To answer questions related to how to use ACASI,
  please refer to the guide for administrators on how to use ACASI (pages 20-21). To answer
  specific questions on the meaning of the survey questions, please refer to the QxQ Guide (pages
  22-34). Note that the majority of participant questions are expected to be about the content and
  meaning of the questions.
- As you remove the SD card from the touch screen laptop, you might move the gray tab on the left side of the card to the "locked" position. Before inserting the SD card into the Data Manager laptop, you must be sure that the card is unlocked by moving the gray tab back up to the unlocked position.

## **ACASI Training Script**

Sit next to the participant and use the following training script to show the participant how to use the touch screen computer, headphones and stylus. (Local language training scripts are available online as separate documents)

MAIN TOPICS	CONTENT
INTRODUCE SELF AND INTERVIEW	Hello, my name is I am going to set up the computer for your interview and show you how it works. If you have any questions at any time, please feel free to stop me and ask. We will work together until you feel comfortable using the computer on your own.
EXPLAIN CONFIDENTIALITY	I want you to know that your answers to these questions are confidential. That means your personal information will be kept private and will not be discussed with anyone else.
EXPLAIN AND DEMONSTRATE HEADPHONES	The interview questions have been recorded on the computer, so instead of me asking you the questions, you will hear them through the headphones. You place the headphones on your head like this [show ppt]. You can adjust the loudness of the voice you hear by turning this knob [show ppt]. Do you have any questions?
EXPLAIN HOW THE PARTICIPANT WILL HEAR AND SEE THE QUESTIONS	You will hear each question and the possible responses on your headphones. If you would like to answer the question before you have heard all of the possible responses, please feel free to do so. However, we ask you to take as much time as you need to think about the best answer to fit your situation. What you hear on the headphones is not "live" [explain more if needed] so you should not answer the questions out loud. Instead, I will show you how to answer the questions using this stylus [show the participant how to use the stylus].
IF PARTICIPANT IS LITERATE PLEASE ADD:	You can read the question at the same time, as it will also be displayed on the screen.
EXPLAIN AND DEMONSTRATE STYLUS	When you are asked a question, you will choose your answer by pressing the computer screen with the stylus. Press the screen lightly and as straight as possible. [show ppt]

EXPLAIN DIFFERENT WAYS TO RESPOND TO QUESTIONS:

**COLORED BOXES** 

**PICTURES** 

**NUMBERED BOXES** 

SUBTRACTING

**ZERO** 

Each question can have 2 to 6 possible responses. You select your response by pressing colored-boxes, or a picture, or a box with a number in it.

For example, if you are asked whether you are a female, there will be a red box next to "No" and a black box next to "Yes." You would press the red box if you are male and the black box if you are female.

For some questions, you may press a picture. If you press the picture, each tap will be included in the final tally for that question. The final tally you have entered will be read aloud by the computer.

If you press more times than you meant to, you can press the black box to subtract from the tally.

You will also be able to enter "0" for some questions by pressing the red box

For other questions, you may press the box with the number corresponding to your answer for that question

<b>EXPLAIN HOW TO ANSWER</b>
COUNT QUESTIONS

For Questions that prompt you to count, **press the picture** to provide the answer. Do not press the box below the picture. The box below the picture will show the number of times you have **pressed the picture**.

If you press the picture too many times, press the black box to subtract from the total count.

## EXPLAIN HOW TO ANSWER CALENDAR QUESTIONS

Calendar questions are for questions involving multiple days.

For calendar questions, respond for each day by pressing the black box (yes), red box (no) or yellow box (do not remember) for that day. After you respond for that given day, press the **green box** at the bottom right of the screen to move to the next day, which will then be highlighted in a **gray highlighted box**. For each additional day, press the appropriate box (black, red or yellow) associated with that day highlighted in gray. Do not press again the box options for previous days you have already responded to, unless you want or need to correct your answers.

## EXPLAIN HOW TO REPEAT A QUESTION

If you need to hear a question again, you may press the picture of the woman at the top of the screen with the stylus.

If you want to go back to the previous question, press the big white box at the bottom left of the computer.
Let's try some practice questions together – the first question asks whether you are a woman. Press the black box once to confirm that you are. After you have answered the question, the computer will tell you to press the green box to go to the next question.
Let's try another practice question. This question asks about your children. You have the option of choosing "0" by pressing the red box or by pressing the picture once for each child you had that was born alive. [May be helpful to give example – "if you have four children, you would press the picture four times"]. After you have entered the number of children you had, the computer will tell you to press the green box to go to the next question.
Let's try another practice question. This question asks about your age and gives you four age ranges to choose from, including "don't know" and then the computer will tell you to press the green box to go to the next question.
[It may be helpful to give an example – "if you are 22 years old, you would press the box indicating 18-24"]
Please press the correct answer now. Do you understand?
Here is another practice question. This question asks about the number of days you went to the market in the past 7 days. Here, you press the box corresponding to the number of days you went to the market in the past 7 days. For example, if you went to the market on two days, you will press the number 2 box.

PRACTICE QUESTION [PQ5] WITHOUT HEADPHONES	Let's try another practice question. This question asks about the meals you ate in the past week. Here, for each day, you have the option of choosing yes by pressing the black box, if you ate a meal on that day or choosing no by pressing the red box if you did not eat a meal on that day, or choosing "do not remember" by pressing the yellow box.
	After you respond for each day, you will press the <b>green box</b> to move to the next day which will then get highlighted in <b>gray</b> . After you have answered for all seven days, the computer will tell you to press the green box to go to the next question. If you need to correct your answer to one of the days, change it before you move to the next question (next screen), by tapping on the correct answer for that day (Show how answers for each day on the calendar can be changed while the calendar is "active" on the screen).
	Let's try with yesterdayPlease press the correct answer now for yesterday. Do you understand?
REPEAT PRACTICE QUESTIONS WITH HEADPHONES	Let's try going through these practice questions again but this time with the headphones.
PAUSE SURVEY	You have done very well in learning how to use the computer and headphones. I think you are ready to now answer the interview questions on your own.
	Do you have any questions before you proceed? [Discuss as needed.]
	Now I'm going to leave the room so you can answer the questions in private. I will be sitting just outside the room if you have any questions. Please remember to take off your headphones and come get me when you are finished or if you have any questions during the interview.

#### Guide for Administrators: Instructions on how to use ACASI

- 1. If the participant has a question about how to proceed from one question to the next say "After answering each question, to go to the next question, press the big green box at the bottom right of the screen."
- 2. If the participant has a question about **how to hear a question again** say "If you want to hear a question again, press the picture of the woman at the top of the screen."
- 3. If the participant has a question about **how to go back to the previous question** say "If you want to go back to the previous question, press the big white box at the bottom left of the screen."

If the participant asks for guidance on how to answer a question, it is important to guide her on how to answer the question using hypothetical answers. Do not ask her what answer she would like to enter. Below are specific instructions on how to answer participant's questions on how to answer a particular question

If the participant has a question about **how to answer a count question with an image response** say "If you have not done this, press the red box. If you have done this, press the picture one time for each time you have done this. For example, if you have done this once, press the picture one time. If you have done this twice, press two times, and so on. If you make a mistake and press the picture too many times, press the black box to decrease the number. If clarification is needed about the maximum number of times the picture can be pressed, you can say "the picture can be tapped up to 60 times. If you want to report an answer that is greater than 60, just tap the maximum number allowed (60)."

- 4. After you have answered, press the big green box at the bottom right of the screen to go to the next question."
- 5. If the participant has a question about **how to answer a Yes/No question** say "If your answer is 'yes', press the black box. If your answer is 'no', press the red box."
- 6. If the participant has a question about **how to answer a Yes/No/I don't know question** say "If you want to hear the instructions again, press the picture of the woman at the top of the screen.

  Listen to the choices that the computer gives you and press the colored box that corresponds with your answer. If your answer is 'yes', press the black box. If your answer is 'no', press the red box. If you don't know or don't remember, press the yellow box."
- 7. If the participant has a question about **how to answer a question with multiple colored boxes** say "If you want to hear the instructions again, press the picture of the woman at the top of the screen. Listen to the choices that the computer gives you and press the colored box that corresponds with your answer. For example, for the practice question that asked you about how

- old you are, If you are between 18 and 24 years old, you would press the black box. If you are between 25 and 34 years old, you would press the red box. If you are 35 or older, you would press the yellow box. If you don't know, you would press the white box."
- 8. If the participant has a question about **how to answer a question with numbered responses** say "If you want to hear the instructions again, press the picture of the woman at the top of the screen. Listen to the choices that the computer gives you and press the box corresponding to the number of times that you did what the computer is asking. For example, if your answer is 2, you would press the number 2 box.
- 9. For the calendar, if the participant says she doesn't remember which days she did something say "We are most interested in knowing on how many days you did or did not do this. If you cannot remember on which day(s) you did and which days you didn't do this, please guess as we would like to know the number of days even if you are guessing which days.
- 10. If the participant has a question about how to answer a **question on the daily retrospective calendar** say, "If you did this on this day, press the black box. If you did not do this press the red

  box. If you don't remember, press the yellow box."

After you respond for each day, press the green box to move to the next day. You will see that you have properly moved onto the next day by seeing it highlighted in **gray**. Respond to the box options for the day highlighted in **gray**, **then move to the next day**.

- 11. Special case: for participants who have been on a product hold or who permanently discontinued study product use, please refer to instructions in appendix F.
- 12. If a visit at which an ACASI interview is required is conducted as a split visit, the entire ACASI interview must be completed on one day. If an ACASI interview is begun, but not completed, on the first day of a split visit, the entire ACASI interview should be administered (starting from the beginning) on the second day of the split visit.

#### Transferring Data from Touch Screen Computers to Designated ACASI Data Manager Computer

At the end of each workday on which at least one ACASI interview is administered, the ACASI Computer data manager will transfer data from the touch screen computers to the ACASI Data Manager laptop computer. The Data Manager laptop is the only one provided to the site that does NOT twist open, as the touch screen laptops do.

- 1. Remove the 2GB Secure Digital storage device (SD card) from each touch-screen laptop computer. Please note: The SD cards match the touch screen laptops, so they must always go back into the same one.
- If the ACASI Data Manager computer is not already turned on, turn it on and enter the secure power-on password.
- If the ACASI Data Manager computer is turned on and you are logged in, log out by pressing Start > Shut Down and then choosing log off username.
- Log back into the ACASI Data Manager computer as the computer administrator, using your assigned user name and password.
- Insert the SD card into the SD card slot on the left side(Lenovo units) or right side(HP units) of the laptop.
- Double click on the ACASI data manager icon, which is located on the Windows Desktop. You will see the dialog box shown in Figure 14 with five (5) buttons.




7. Click the first button in the Data Manager Dialog box, which reads "Merge data from SD card to ACASI database." This will copy the new data from the SD card into the ACASI database maintained on the laptop, which is located in the C:\ACASI\DATA

folder. After the data are successfully transferred, the transfer program will delete the data from the SD card.


N.B. If you have not inserted the correct SD card, you will see the error message below:



Also note that as you remove the SD card from the touch screen laptop, you might inadvertently move the gray tab on the left side of the card to the "locked" position. Before inserting the SD card into the Data Manager laptop, you must be sure that the card is unlocked by moving the gray tab back up to the unlocked position. If you have locked the SD card before inserting it into the Data Manager laptop, you will see this error message.







- 8. After the data are successfully transferred, the transfer program will delete the data from the SD card.
- 9. If the data are not successfully transferred, please note the error and **email a description of the problem to MTN003acasisupport@mtnstopshiv.org**
- 10. Remove the SD card from the data manager laptop and insert it in the touch-screen computer immediately to make sure they are kept together.

After completing the data transfer from all the touch-screen computers that completed ACASI questionnaires to the data manager computer, then proceed to backing up the data to your assigned USB key, and then to uploading the ACASI database.

## **Backing Up the ACASI Database**

At the end of each workday on which at least one ACASI interview is administered, after transferring data from touch screen ACASI computers to the designated ACASI laptop and uploading the ACASI database to the MTN SDMC (i.e. SCHARP) via the ATLAS portal, the ACASI Computer data manager will back up the ACASI database and Windows Event Logs to the assigned portable data storage device (USB key).

- 1. If the ACASI laptop is not already turned on, turn it on and enter the secure power-on password.
- 2. If logged in, log out of the laptop by pressing Start > Shut Down and then choosing log off username.
- 3. Log back into the laptop as an administrator, using your assigned user name and password.
- 4. Insert the assigned USB key into one of the USB ports on the left side of the laptop.
- Double click on the ACASI
   data manager icon located on
   the Windows Desktop. You
   will see the dialog box shown
   in Figure 15 with five (5) buttons.



- Click the third button in the Data
   Manager dialog box, which reads "Backup ACASI database to USB key."
- A pop-up window will confirm that the backup has been successfully completed and a window will open up which displays the files that have just been backed up.
- 8. Remove the memory key by **right** clicking on this icon on the task bar and then left clicking on **Safely Remove Hardware.** Click **USB Mass Storage Device**, and then click **Stop**. Click **USB Mass Storage Device** again, and then click **OK**, and then **Close**. You will see a message pop up on the task bar, telling you that it is safe to remove the hardware.
- 9. The USB backup key should be stored securely and in a dry location, in a locked **cabinet**.

## Technical Notes on Data Backups

The source ACASI data folder is C:\ACASI\DATA. This is the location in which the ACASI Access database resides.

The ACASI backup program utilizes the compression utility WinZIP to ensure optimum drive space utilization. A backup is performed on the following databases and files:

- 1. The ACASI database ACASI\_VOICE\_DATA.mdb
- 2. Windows computer System Event Log
- 3. Windows computer Application Event Log
- 4. Windows computer Security Event Log
- 5. System.mdw
- 6. RespondentResponses.xml

The backup program creates unique backup files of each database each time a backup is run. This is done to prevent overwriting backup files. Each backup file will be date and time stamped within the backup filename. Additionally, a unique backup name is created for each laptop computer.

The backup filename will indicate the database file that was backed up, followed by the date, time, and assigned ACASI computer name.

Each backup file is compressed and encrypted with the assigned password "ptw472".

When a merge from the SD card is done, the compressed files are stored in date-stamped folders in the C:\acasi\backup directory on the hard drive. The purpose of the USB key is to add an extra level of safety in case the hard drive crashes.

If the automated backup to the USB key does not function properly, please follow the steps below to perform a manual backup. You can simply copy the backup files just like you would with any other file.

- 1 Open Windows Explorer or My Computer.
- 2 Navigate to the C:\acasi\backup directory.
- 3 Select the current date's folder. For example, the files for April 9, 2008 will be in a folder labeled 04092008.
- 4 Select the folder then copy and paste it to the USB key. The drive letter of the key will most likely be E:

## Uploading ACASI Data to the SCHARP Atlas Portal

At the end of each workday on which at least one ACASI interview is administered, after transferring data from the touch screen ACASI computers to the designated data manager computer, the ACASI Computer data manager will upload the ACASI database to the MTN SDMC (i.e. SCHARP) via the ATLAS portal.

1. If the data manager program is not open, double click on the ACASI data manager icon on the Windows Desktop.

Recording Environment

In order to ensure the best recordings as possible, please do the following:

- 1. Select a quiet location. It is recommended that recording be performed in a private room, or an area that is walled off from others.
- 2. Ensure the equipment is set up; this includes the headphone in the proper position.
- 3. Read the audio script in a calm but assertive voice.
- 4. Note that over time you may get tired, so it would be good to take breaks to ensure an effective creation of the audio files.





#### **Instructions**

Each site will be responsible for conducting a thorough review of the local language versions of the behavioral assessments for the MTN-003 (VOICE) trial administered through **Audio Computer-Assisted Self Interview (ACASI)**. Both the audio recording and the written text of the recording will need to be thoroughly reviewed and approved by the site Investigator of Record (or designee).

The purpose of the local language(s) review is to ensure that:

- a) All local language translations accurately reflect the intended meaning of the original ACASI English text
- b) The translated text accurately documents the local language audio recordings
- c) All translations are grammatically correct
- d) All translations will be understandable to VOICE participants
- e) The pace and volume of the audio-recording are appropriate

Each site will conduct the following steps when reviewing the local language versions of the ACASI text and recordings:

- A minimum of two designated study staff members who speak the local language will review the ACASI Translation Table to make sure that translations reflect the intended meaning of the original English ACASI text, are grammatically correct, and understandable to VOICE participants.
  - a. If the translations are accurate, a designated study staff member signs each page of the Translation Table to confirm that the translated text accurately reflects the meaning of the original English ACASI text.
  - b. If translation errors are found, designated study staff members will make all necessary changes, highlight changes in the Translation Table, and then a designated staff member signs each page of the Translation Table to confirm that the updated translated text accurately reflects the meaning of the original English ACASI text. The designated staff member who signed the Translation Table will ensure that these changes are also made in the audio recordings.
- 2. A minimum of two designated study staff members who speak the local language will listen to all local language audio recordings for the VOICE ACASI program to make sure they accurately reflect the reviewed translated text and that the pace and volume of the files are appropriate. If errors are found, the designated staff members will inform Stan Mierzwa (<a href="mailto:smierzwa@popcouncil.org">smierzwa@popcouncil.org</a>) from Population Council and ensure that the erroneous files are rerecorded in collaboration with Population Council.



This means that no study product has been re-supplied/re-issued to the participant in the 4 weeks or more before the current visit date, and that the participant did not have any remaining unused product (regardless of expiry) in her possession in the 4 weeks or more before the current visit date. This applies to product holds/discontinuations that are initiated by site staff, as well as cases where a participant chooses on her own to stop using study product for any length of time.
  - Site staff should administer the <u>Product Hold/Discontinuers/SEV</u> ACASI questionnaire at the participant's quarterly, semiannual, and annual visits. Site staff should continue to administer this same questionnaire to her at all subsequent quarterly, semiannual, annual, and PUEV visits where she has not been exposed to study product in the 4 weeks or more prior to the visit.
  - If a participant had any unused product in her possession in the 4 weeks prior to the current visit date (regardless of whether or not she is on a site-initiated product hold/discontinuation, and regardless of whether or not she has used the study product), the participant should be administered the regularly scheduled ACASI questionnaire.
    - When she completes the regularly scheduled ACASI questionnaire, she will be asked questions to rate her ability to use study product as instructed. The participant should respond based on her experience during the days she was expected to use study product; that is, the days where she did not have a site-initiated product hold or permanent discontinuation, if any. For the calendar questions (e.g., question 25), she should respond "NO" for the days in which she did not use study product. For all other product-related questions (e.g., question 26 and beyond) she should respond based on her experience during the days she was expected to use study product. Note: clinic staff must provide these additional instructions to the participant prior to the start of her ACASI interview.
  - 3. If a participant is placed on product hold <u>AT</u> a quarterly visit, she should complete the regularly scheduled quarterly (semiannual or annual) ACASI interview as she was expected to use product up to that visit date. If she remains on hold until the <u>next</u> quarterly visit, she would then be administered the Product Hold/Discontinuers/SEV at that next quarterly visit.

#### Procedures for participants who terminate early from VOICE

4. For participants who terminate from the study prior to their expected product use end date, the PUEV is conducted at the study month when the participant terminates from the study. For example, a participant is expected to remain on study product for the minimum amount of time allowed per protocol (12 months). The participant presents to the site clinic for her Month 5 visit and informs study staff that she no longer wants to participate in the study. If the participant is willing, study staff conduct the PUEV at this time (Month 5) and administer the Annual/PUEV Oral or Vaginal questionnaire, as appropriate.
