



PPD & SMILE Support Activities


- PPD GCLP-related activities
 - Conduct GCLP audits and generate associated reports
 - Support GCLP training activities
- SMILE (key support activities)
 - Create audit report action plans and oversee report resolution activities
 - Coordinate and oversee EQA related activities
 - Provide guidance on GCLP standards compliance
 - Provide on-site or remote trouble-shooting/training support



Laboratory Oversight Team

Laboratory oversight is a collaborative team effort involving all stakeholders

To promote reliability, quality, consistency and integrity of clinical data; and the safety of participant & lab staff





DAIDS GCLP Audit Process Working Group (DGAPWG)

- DGAPWG (members: DCLOT, SMILE, FHI/PPD, Network, Site lab)
 - Overarching goal
 - To improve the effectiveness of the DAIDS GCLP audit process
- Highlights from site laboratory survey
 - SMILE support is highly valued
 - Audit and report resolution process very beneficial but suggested improvements needed
 - Request for trend analysis
 - Request to reduce audit report resolution timelines
 - Auditor-related concerns
 - Knowledge of GCLP and relevant local standards
 - Audit debriefing information
 - GCLP training preference
 - Harmonization of network laboratory activities
