

# MTN-042 Operational Guidance #03: End of Cohort 1 Accrual

This operational guidance document provides instruction to sites regarding the end of cohort 1 accrual.

Based on reported screening and enrollment numbers as of 30 March 2021, it is anticipated that MTN-042 cohort 1 accrual will reach the targeted N=150 participants as of 6 April 2021.

- Effective immediately, sites are instructed to discontinue conduct of any MTN-042 screening visits.
  - If screening visits are scheduled on 31 March 2021, these may proceed per the discretion of the site IoR, but participants should be advised that the study is likely to complete accrual prior to their scheduled enrollment. Sites are asked to please notify FHI 360 of the scheduled enrollment dates for any screening visits completed on 31 March 2021.
  - All scheduled screening visits after 31 March 2021 should be canceled, and participants counseled accordingly (e.g., provided results of all screening labs, provided information about MTN-043, if interested).
- Sites should proceed with all scheduled enrollments through 6 April 2021. For enrollment visits scheduled *after* 6 April 2021, sites are asked to tentatively maintain these visits as backup—these visits will only proceed if the study has not met the cohort 1 accrual target of N=150 by 6 April 2021 and the site receives a specific request from FHI 360 to conduct an additional enrollment visit.
- Sites are asked to report daily to FHI 360 whether the enrollments scheduled for that day were successful.
- Sites should also report to FHI 360 if any enrollment visits are rescheduled to a different date.
- Sites will be notified via email when cohort 1 is confirmed to be fully enrolled.

All Operational Guidance documents must be printed and filed with study essential documents.

### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Family Health International Inc - Part 11 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

# **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

## Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. ## Consequences of changing your mind
