

MTN-032 Data Communiqué #5 – 03 AUGUST 2018

CRF CLARIFICATIONS

Participant Status Form (PSF) CRF Completion Clarifications

- 1. General Information/Instructions: This form records essential administrative information about individuals who are randomly selected, screened and/or enrolled into MTN-032. This form will be completed for every HOPE participant/ HOPE participant's partner who is randomly selected for participation in MTN-032 Phase 2 until the point on the randomization list that the target number of enrollees for that subgroup is met.
- 2. Items 1 and 1a: These should only be completed for former HOPE participants who enroll into MTN-032.
 - a. *Do not complete* these items if a potential female participant **does not** enroll into MTN-032.
 - b. *Do not complete* these items for male partners, regardless of whether they enroll into MTN-032.
- **3. Comments:** The Observation Number (outlined in Figure 1) on the SCHARP Recruitment List should be noted in PSF comments for all participants.

Previously Completed PSF CRF for Non-Enrolled Participants

- PSF CRFs previously completed should be updated by the site team to delete the HOPE PTID for male partners and for individuals who did not enroll into MTN-032 as follows:
 - a. The HOPE PTID should be crossed out with a single horizontal line through the entry, "DELETE per DC#5" should be written near the boxes, and the correction should be initialed and dated per SSP Appendix 7-5 and Good Clinical Practice (GCP).
 - b. The updated PSFs should then be re-submitted to RTI.
 - c. Previous electronic copies of the CRFs should be archived.

Clarifications regarding Recruitment List reporting to RTI

- Remove the HOPE PTID column from male and female Recruitment Lists prior to submitting accrual numbers to RTI.
 - a. If completing electronically, save a version of the list for submission and delete the HOPE PTID column from this version prior to submitting to RTI.
 - b. If completing by hand, follow the above guidance for deleting HOPE PTIDs prior to uploading and submitting to RTI.

- 2. For ALL individuals considered for enrollment into MTN-032, write the enrolled or non-enrolled PTID in the 'MTN-032 PTID' column per updated recruitment lists from SCHARP (see Figure 1. below). Write the date the participant was enrolled, deemed ineligible or declined participation in the 'Date Enrolled, Ineligible, or Declined' column'.
 - a. Complete these columns for all individuals considered for enrollment until accrual subgroup target enrollment is met.
